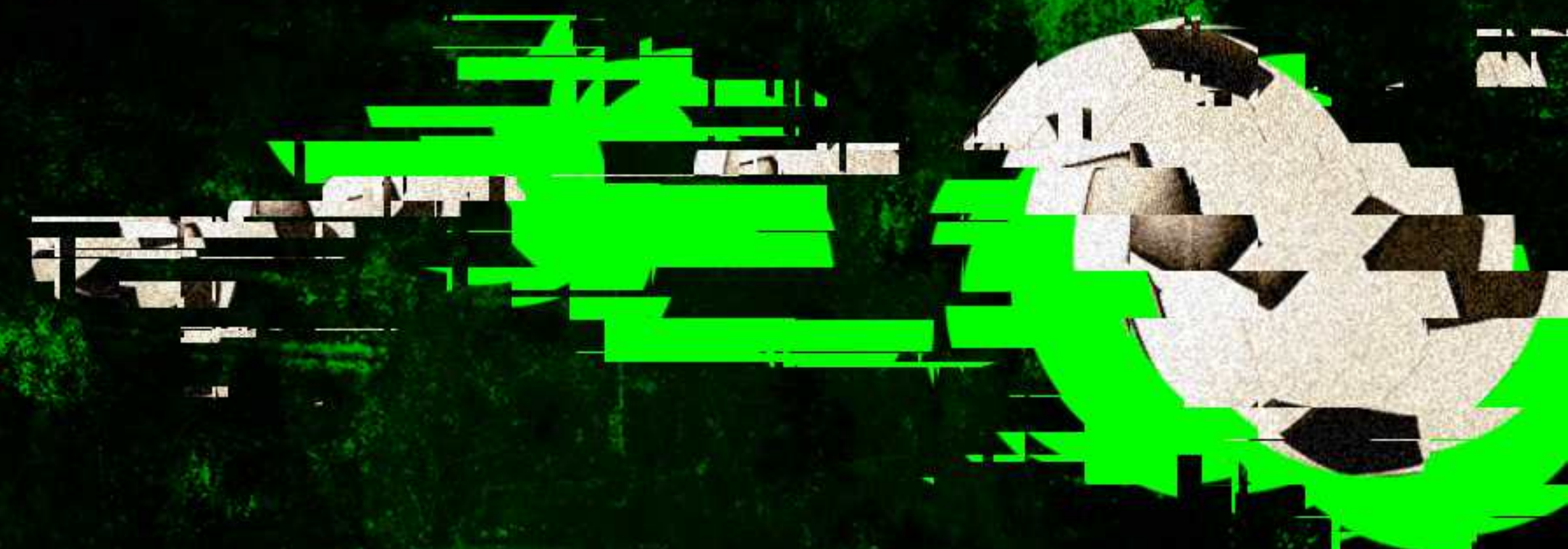

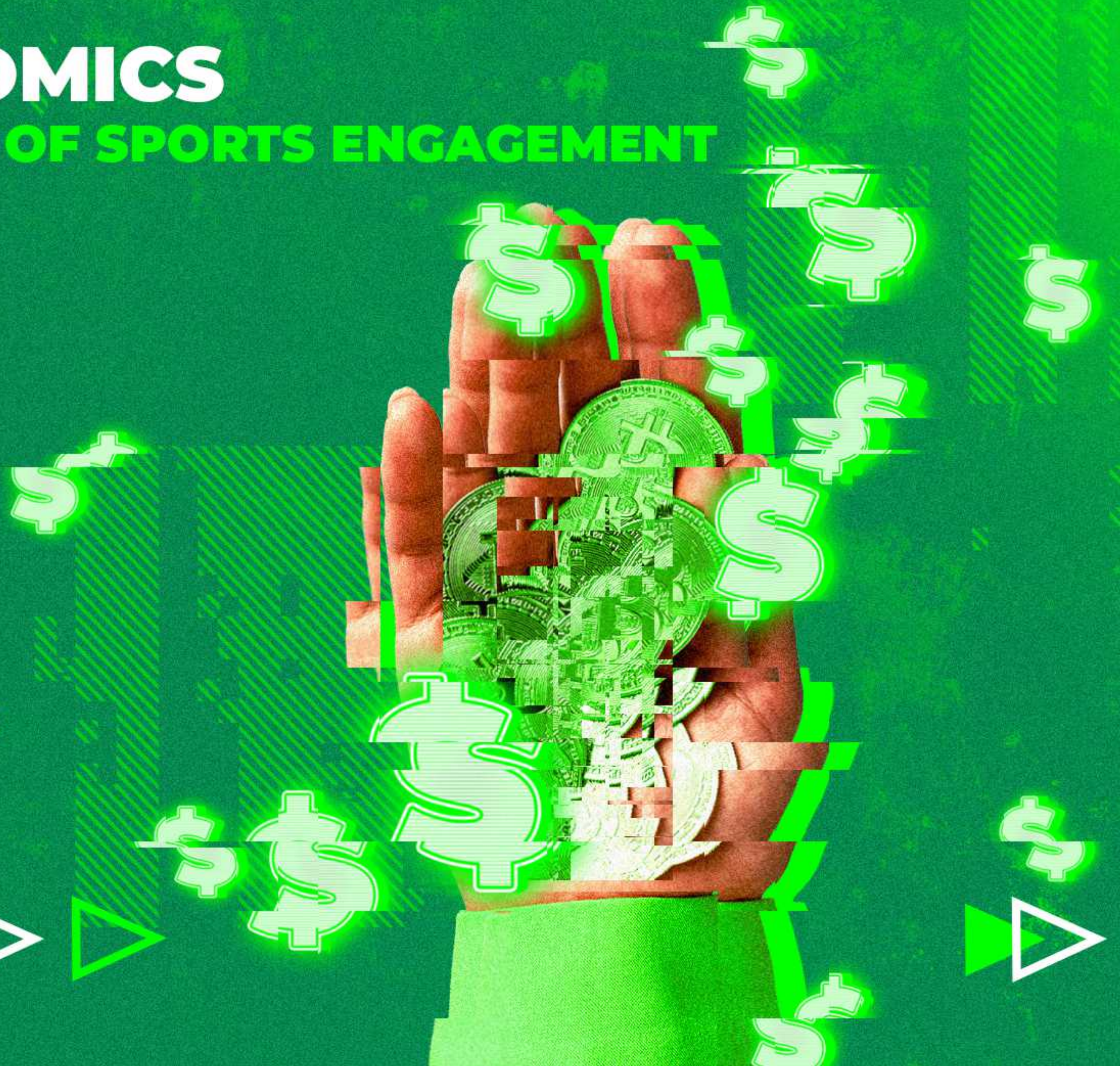

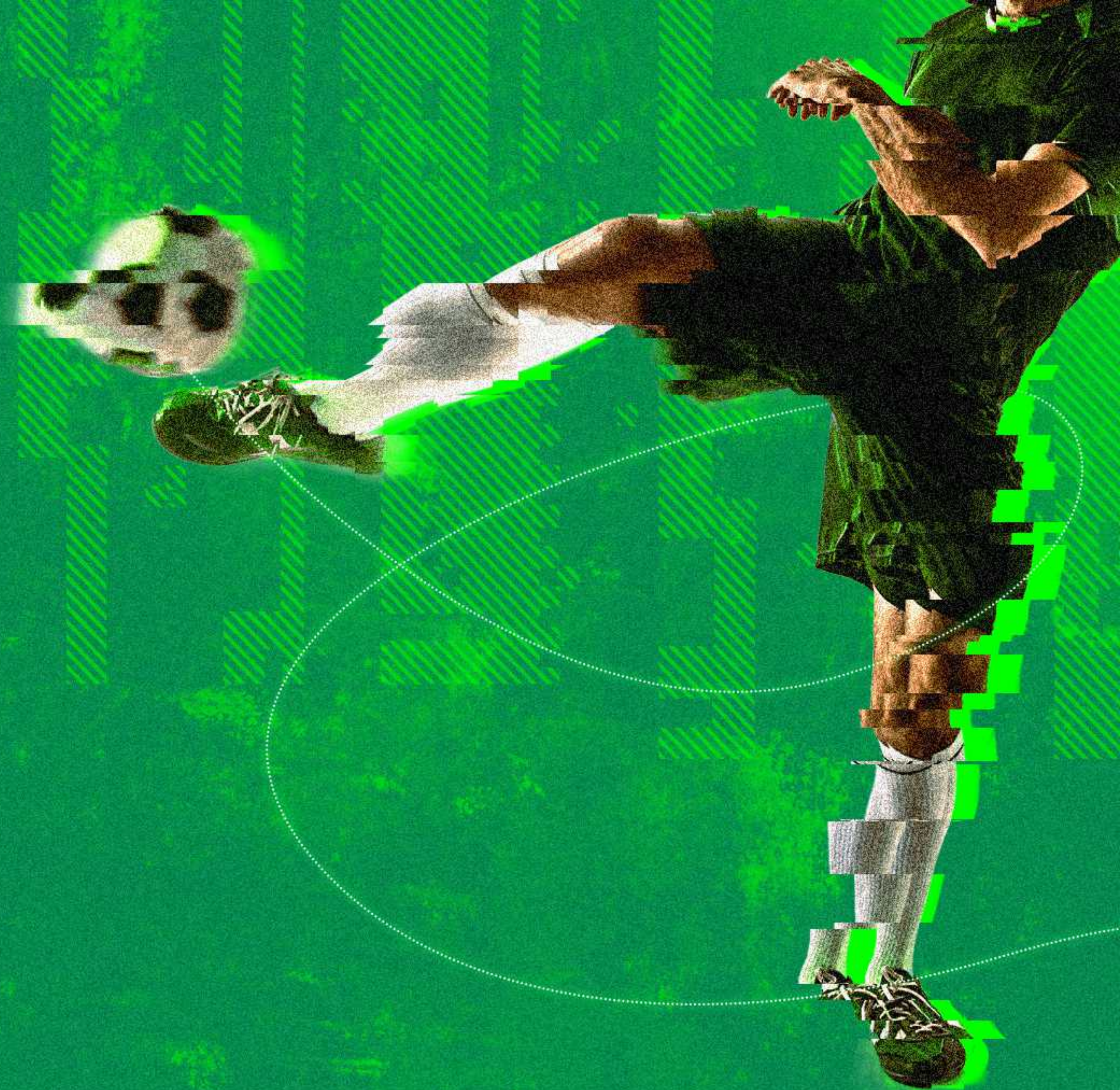

# LISTING PHASE

Following the conclusion of the pre-sale, the \$PLAYR Listing will commence:

- # All unsold pre-sale tokens will be burned.
- # The Listing will be conducted on both centralized exchanges (CEXs) and decentralized exchanges (DEXs), including PancakeSwap & MEXC.
- # All tokens raised during the Listing, along with funds from the liquidity pool, will be used to establish robust liquidity on exchanges.
- # A vesting schedule will be implemented for the remaining tokens, utilizing a cliff and graded vesting model, with distributions to project contributors occurring after a predetermined period.



# UTILITY FEATURES

- # Additional rewards are provided through a 1% share of all transaction fees generated within the OnePlayr.com network.

## 2. \$FAN TOKEN:

- # \$FAN tokens are generated based on the limited supply of \$PLAYR tokens.
- # While \$FAN tokens cannot be sold, they unlock a range of benefits within the ecosystem:
  - # Unlocking exclusive app features
  - # Discounts on NFT and merchandise purchases

## 3. \$FAN DAO:

## VESTING SCHEDULE

To ensure the long-term commitment of the team and incentivize sustainable growth, a vesting schedule will be implemented:

- # **Cliff Period:** 6 months
- # **Graded Vesting:** 25% released after the cliff period, followed by 25% annually

## EXCHANGE LISTINGS

\$PLAYR will be listed on both centralized exchanges (CEXs) and decentralized exchanges (DEXs) to provide maximum accessibility and liquidity for token holders. Tokens allocated for the Listing and liquidity provision will be distributed across various DEXs and selected CEXs.

## TRANSACTION FEES

A nominal 2% fee will be applied to all \$PLAYR token transactions. This fee structure supports the on-going development and sustainability of the OnePlayr ecosystem:

- # **Community Fund (1%):** 1% of each transaction fee will be allocated to a dedicated wallet designated for charitable causes. The OnePlayr community will have the power to vote on the allocation and distribution of these funds.
- # **Staking Rewards (1%):** The remaining 1% of each transaction fee will be distributed proportionally to all \$PLAYR stakers, rewarding their commitment and contribution to the network's security.

# SECURITY MEASURES

## COMPREHENSIVE SECURITY AND TRUST MEASURES

Ensuring the security of our ERC721 smart contract and the broader ecosystem is paramount to maintaining trust and reliability for our users. To achieve this, we employ a multi-layered security approach that encompasses both external and internal measures.

## EXTERNAL SMART CONTRACT AUDITS

We engage external smart contract audits from known and trusted providers. These independent audits scrutinize our contract code for vulnerabilities and potential exploits, providing a crucial third-party validation of our security measures.

## COMPANY KYC

Our organization undergoes comprehensive Company-KYC procedures. These processes help establish the legitimacy and integrity of our operations, ensuring that all stakeholders are verified and that the platform operates within legal and regulatory frameworks. This adds an additional layer of trust for our users and partners.

## MILITARY-GRADE SECURITY AUDITS

Beyond standard audits, we subject our system to rigorous external military-grade security audits. These audits employ advanced techniques and methodologies typically reserved for high-security applications.



## INTERNAL QUALITY ASSURANCE (QA)

Internally, our Quality Assurance (QA) team performs meticulous reviews and testing of all code. This includes continuous integration and deployment processes that help identify and resolve issues swiftly.

# VERSIONING

## REASONS BEHIND VERSIONING

### SEAMLESS UPGRADES

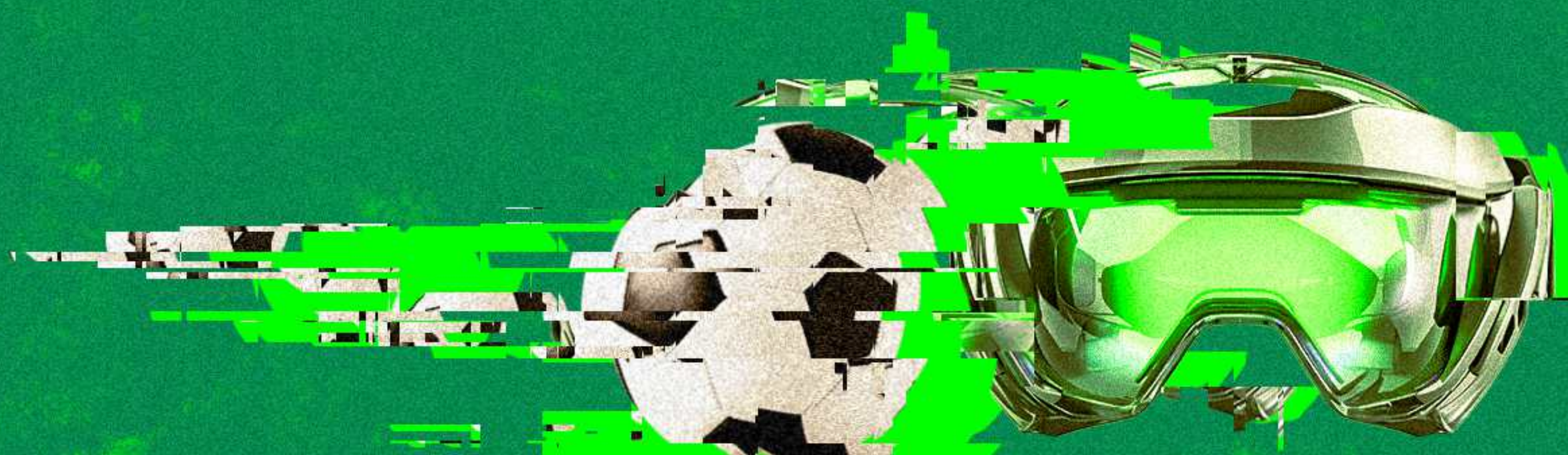
By using proxy contracts, we can deploy new versions of our smart contract logic without requiring users to interact with a different address. The proxy contract remains the constant point of interaction, forwarding calls to the latest implementation. This seamless upgrade capability ensures that users always interact with the most secure and feature-rich version of the contract, benefiting from improvements and fixes immediately after deployment.

### DATA CONSISTENCY

One of the significant challenges in upgrading smart contracts is maintaining data consistency. With proxy contracts, the storage layout is kept intact, as the state variables reside in the proxy itself rather than the logic contracts. This means that even when the logic is upgraded, the data remains consistent and preserved. Users can rest assured that their NFTs and associated metadata are stable and secure across contract versions.

### REDUCED DOWNTIME AND COSTS

Implementing proxy contracts reduces the downtime typically associated with deploying new contract versions. Since the proxy contract address does not change, there is no need for users to update their records or for the project to migrate data manually. This approach also minimizes the gas costs involved in redeploying and initializing new contracts, making the process more efficient and cost-effective.
